STAND UNITS

The stalls are clean surfaces as described below. The exhibitor must bring with him everything necessary for the design of the stand (partition walls, tables, shelves). Chairs are available. The objects brought along must not protrude beyond the stated standard measurements. Note: it is allowed to lean objects against the walls, but not to mount, attach or fix anything with glue. The stalls must be self-standing.

STAND SIZES AND PARTICIPATION FEE

The rents are valid for the all days of the event and include all charges for electricity / marketing / public relations.

They are calculated as follows:

/// 1 STAND UNIT (2.00 m wide x 2.00 m deep)

Price: 320.00 EUR plus VAT

/// 1,5 STANDS (3.00 m wide x 2.00 m deep) - limited number available

Price: 480.00 EUR plus VAT

/// SPECIAL FORMAT (3.00 m wide x 3.00 m deep)

Price: 720.00 EUR plus VAT

It goes without saying that several stand units can be booked.

ELECTRICITY

The function rooms are lit by default. We recommend planning an individual stand lighting. The exhibitor is responsible for the operational safety of the used equipment. If defective devices cause a power failure, there will be a fine of 500 euros.

BOOKING

After completion of the registrations (deadline 30th of August 2021), the organizer will select the participating exhibitors and send them an acknowledgment or cancellation by 15th September 2021 at the latest. The organizer decides on admission in its own discretion and can reject applications without justification. The organizer sends a corresponding invoice for the due booth-rental by email to the exhibitor. The booking is binding only with the payment of the stand rental. By transferring the stand rental, the exhibitor agrees to all conditions of participation stated here.

3-YEAR RULE

THE 3-YEAR RULE DOES NOT APPLY THIS YEAR! Explanation: In order to offer our visitors variety, we accept each exhibitor for a maximum of 3 consecutive years. The fourth year must be suspended. The following year can be attended again.

No legal claim can be derived from this regulation. The DillyDally team reserves the right to make individual decisions in exceptional cases (for example, not enough exhibitors in a category).

PAYMENT AND CANCELLATION TERMS

The stand fee has to be fully paid 01 October 2021 at the latest. In case of non-payment by the specified date, the organizer reserves the right to assign the stand to someone else.

In case of a cancellation up to four weeks before (6th October 2021), the organizer reserves 30% of the stand rental fee as a processing fee. For cancellations from 7th October 2021, the stand fee will no longer be refunded.

PROCEDURE OF THE EVENT

Opening hours: Saturday, November 06th, 2021 from 12 am to 8pm

Sunday, November 07th 2021 from 10am to 6pm

STAND CONSTRUCTION AND DESIGN, SHARED USE BY THIRD PARTY, SUB-RENTAL

The stands must be set up before the start of the event and may not be cleared in whole or in part before the end of the event and without consultation with the organizer. In case of non-compliance, we allow us to collect a contractual penalty of 200 euros. The specified standard dimensions are marked and must be adhered to during assembly. The maximum stand height of 2.50 m must never be exceeded.

For optical reasons we ask you not to use banners or roll-ups! **If you are planning a stand concept with closed walls or also a closed back wall**, please let us know immediately after the commitment, so that we can place you accordingly meaningfully.

As an exhibitor, you undertake to equip a stand with the products registered with us and to keep them staffed during opening hours. A shared use of the rented stand space by third parties is only allowed after consultation with the organizer. Subletting of the allocated area is not permitted.

All materials used for decoration in the stand must be flame retardant according to DIN 4102 (fire protection class 1). The use of straw, fir green or similar materials as well as burning candles and any kind of open fire is prohibited. Likewise the purchase of food and drinks is not allowed.

LIABILITY STAND

The exhibitors undertake to leave the stand space as it was found, otherwise the resulting costs will be forwarded to them. This applies particularly to the possible damage to the stand surface (walls, foot floor), as well as for the waste disposal (packaging, leftovers etc.). In case of damage, the renter is obliged to inform the organizer without delay.

In addition, the exhibitor is liable for his own goods at any time, as well as for simple or gross negligence of his employees with regard to personal injury and property damage. The organizer takes over the general guarding of the event rooms, but without liability. Similarly, the organizer is not liable for theft. The conclusion of an exhibitor insurance is recommended.

FAILURE OF THE EVENT

If the event can not take place due to force majeure or other important reasons not caused by the organizer, the organizer undertakes to reimburse the exhibitor for the participation fee. All other costs (such as travel expenses, production costs) are in any case borne by the exhibitor himself. Claims for damages against the organizer can not be asserted.

FILMS AND PHOTOGRAPHS

The organizer is entitled to photograph and film during the event as well as to release the material for promotional purposes. The same applies to the press approved by the organizer.

ENTRY

The Entry Fee is 12 EUR. Each exhibitor will receive two exhibitor passes before the start of the event. Two sellers who must be named in advance per booth are allowed. Free tickets are not issued.

DILLYDALLY HOMEPAGE

We want to present you on our website in the best possible way. For this we give you already during the registration process the possibility to upload your data, pictures or links to your homepage / products. Please upload only content that belongs to you or you own the appropriate license. Pornography, prohibited or illegal content will not be tolerated and immediately deleted and you are liable as a participant in full for the resulting damage.

DATA PROTECTION

We comply with the, from 25 May 2018 coming into force, data protection regulations according to DSGVO. These can be read on the website. We require data from our exhibitors (such as name / label / address / telephone number / Billing address / e-mail address / tax numbers or ATU / picture material or link to the products) so that we can carry out the application process including invoicing. Sensitive data, such as tax number or billing address will be deleted after the selection process, you should not participate in the market. If you subscribe, your data will remain until the next market update.
